## Mission

The purpose of the COE is to provide the Commissioners of St. Mary's County with education, advice and assistance concerning the protection and preservation of our county's natural resources and fragile environment.

## Meetings

The Commission meets at 6:30 pm on the first Tuesday of every month. Public participation is encouraged.

## Highlights of the Commission's Work

- Held a successful workshop in February 2022 on native plants attended by over 100 residents of the County.
- Awarded the Commission's annual sustainability awards to four programs in recognition of their leadership in promoting environmentally sustainable practices in the County.
- Recommended that the County adopt a goal of obtaining 100% of its electricity from renewable energy sources by 2030.
- Began planning an event to celebrate Earth Day with Summerseat Farm in April 2023.

#### Workshop on Native Plants

- On February 19, 2022, the Commission held a workshop on native plants attended by over 100 residents of the County. The workshop examined the ecological benefits of native plants and practical approaches for obtaining and using them. Presenters at the workshop included:

#### **Sustainability Awards**

Sustainability awards are the flagship project of the Commission. Program goals are to encourage continuous environment improvement by recognizing outstanding St Mary's County students, restaurants, businesses, non-profits and farms for their environmental stewardship, resource conservation, innovative best practices, and pollution prevention. The winners of the award receive publicity for their achievements and an award plaque.

The 2021 St Mary's County Sustainability Award winners were:

Restaurant: Enso Kitchen School: Captain Walter Francis Duke Elementary School Non-Profit: Master Gardeners (UMD Extension) Business: Bay Fibers Studio Honorable Mention: Ryken High School, Maryland Earth Preservation Organization (MEPO)

Each of the awardees have incorporated sustainment-focused practices into their organizations. Enso Kitchen serves locally grown and produced food and Bay Fibers Studio promotes our local native environment while also donating proceeds to Chesapeake Bay conservation and other environmental causes. The volunteers that make up the University of Maryland Extension Master Gardeners have worked tirelessly to incorporate native plants in landscape design projects and in leading County residents and businesses in installing interpretive boards for others to learn about wetlands, native trees and buffer zones. Lastly, Duke Elementary School students and teachers have an active garden club, support pollinators by planting native flowers, incorporate signage to limit paper towel waste, and have a very popular walk/bike to school program. Receiving an honorable mention was the Maryland Earth Preservation Organization for increasing their efforts to bring environmental topics to even more students.

#### **Resolution to Promote Renewable Energy in the County**

The Commission recognizes the environmental and economic benefits of using energy from wind, solar and other renewable resources. After several meeting and considerable discussion, the Commission adopted a resolution recommending that the County establish "a one hundred percent (100%) renewable energy goal for county government electricity use by the year 2030."

#### Other Issues of Interest to the Commission

The Commission held discussions on a wide range of other issues, including

- Promotion of composting as an element of the County's comprehensive solid waste management plan.
- Adoption of policies, including a solar zoning ordinance, that encourages increased development of solar energy in St. Mary's County.
- Trash cleanup in the County.

The Commission maintains an active Facebook site that focuses on environmental issues of concern to the residents of St. Mary's County. The goal of that site is to educate citizens on important environmental issues, encourage active individual citizen participation in protecting the environment, and highlight and support the work of organizations, businesses and agencies working to achieve a cleaner county.
