## Chairman's Remarks:

-St. Mary's 2050: George will continue to track public input the county is receiving regarding development around the airport and the Innovation District.

# **DPWT Report:**

- Regarding St. Mary's County 2050, Allison Swint noted the county website gives additional details.



-Gary Whipple gave a report on runway and taxiway extension projects. A new schedule has been developed as we are nearing temperatures which allow paving to commence.

Three key dates have been projected:

24 March: Relocate threshold to previous location to finish paving

31 March: Pavement control strip installation for analysis

09 May: Paving finish

- -New runway markings and lighting will be installed in May. Following these installations the FAA will flight check the new runway end identifier lights (REIL), Precision Approach Path Indicators (PAPI), (runway 29 PAPI will also be replaced) and edge lighting. Cost share agreement with FAA in work with agreement projected in place before end of runway work.
- The new schedule is aggressive but allows for some weather delays. The contractor is trying to double up paving crews and is modifying subcontracts to allow Allan Myers (asphalt supplier) to also perform paving work in addition to providing asphalt. (Previously the prime was doing all the paving work). New subcontractor work sharing should increase project efficiency.
- -Further update on requesting federal grant funds in the 2026 2027 cycle to start funding for runway rehabilitation. Initial funding will be for runway design.
- -DPWT is also working on a federal grant application due in June 2025 to update the airport master plan and layout plan. Draft scope of work between DPWT and contracted airport consultant is under review. Final scope of work is projected to complete in April and will then be presented to the county commissioners in June for approval before final submission to the FAA. Planning is estimated as a two-year process and will include focus groups and public input sessions. This work is normally 90% federally funded and 10% county funding.
- -Allison Swint is still pursuing a second contractor to obtain a bid for the replacement airport automated weather observation system (AWOS). The second contractor is not responding to requests, and she is giving the company until the end of the week before moving forward. Allison also noted the taxiway lights are still out of service due to electrical problems and there is no update on repair timelines.

**FBO Report** – Ken Reed spoke for the FBO and had nothing to report other than an update to his efforts to expand cell phone service on the airport. He has been in touch with T-Mobile to indicate desire of adequate cell service at the airport.



## Pax Air Ops Report:

LCDR Hughes discussed a recent flight safety issue where an aircraft departing 2W6 circled up east of the field and had a near-miss with an aircraft in the runway 14 approach corridor to NAS Patuxent River. The aircraft was not in communication with Pax approach. Further discussion between board members and meeting attendees centered around how currently published airfield and AWOS guidance is stated. Current guidance is:

"When Pax Rwy 14 in Use, 2W6 Acft Cross Approach Path At or Blw 1000 Ft or Above 3000 Ft."

The issue, as discussed, was that it was not feasible for pilots to discern whether NAS Pax is using runway 14. The NAS Pax ATIS frequency is UHF only (civilian aircraft only have VHF radios) and in any event even if other runways are in use, there may be practice approaches to runway 14. Matt DiMarco suggested the words "When Pax RWY 14 in Use" be removed from the airfield / AWOS guidance to suggest pilots should avoid these altitudes at all times to remove conflict.

Allison noted AWOS guidance can be updated by the county. Airport Facility Directory guidance is updated via the FAA.

It was decided this topic would be brought up at a planned spring 2W6 pilots / NAS Patuxent River safety meeting.
