Vice Chairman Sacks called the meeting to order at 1: 00 p.m. A motion was made by Member Cullins to approve the May 9, 2011 minutes as submitted and it was seconded by Member Currie. Motion carried. Vice Chairman Sacks read a letter into the record from Chairman Saldaña regarding the approval of license applications.

- Buffalo Wild Wings Grill & Bar

Application of Christopher Andrew Ramsey, Philip Michael Goodenough, and Crystal Darlene Hill to purchase a Class B (Restaurant) BWL license and t/a Buffalo Wild Wings Grill & Bar (BWW Lex Park, LLC), 22555 Three Notch Rd., Bldg.
