At this event, there were six Tomorrow's Women nominees, with twelve Women of the Year nominees. We provided a gift bag to all awardees with informational resource materials, along with a few trinkets to remember such an outstanding event. The winners were recognized with a trophy. We received much positive feedback about the event and donated the proceeds to the Jane Hale Sypher Scholarship Fund at the College of Southern Maryland.
