**Background:** The St. Mary's County Commission for Women (CFW) was established in July 1976 as a result of legislation passed by the Maryland General Assembly to address matters of specific concern to women. The St. Mary's County Commissioners appoint members.

**Mission:** To celebrate and support St. Mary's County women through outreach, advocacy and service to secure an equitable community for all.

The Commission for Women (CFW) is a very active group. The group strives to stay informed of current issues and trends and shares that information with county leaders. A priority for our members is recognizing women of St. Mary's County who make significant contributions to our County through volunteer work. The Commission continues to support the Jane Hale Sypher Scholarship through funds raised at the Annual Women's History event. The Jane Hale Sypher Scholarship Endowment currently stands at \$65,740 and generated \$1,172 for the 2025-2026 academic year. Two \$1,000 scholarships were awarded for the 2024-2025 academic year to Jasmine King, with a 3.5 GPA in Arts & Sciences and Samantha Knopp with a 3.6 GPA in Cybersecurity. For the 2025-2026 current academic year Miranda Cook with a 3.6 GPA in Business Management. Thirty-three scholarships have been awarded since its inception in 2010.

This scholarship differs from most as it is designed to help returning students over the age of 25 and can be used for part-time enrollment.

The issue of violence against women remains a top priority and is a complex topic that requires multiple partnerships and coordinated efforts. We have member agencies serving on the Family Violence Coordinating Council who represent the citizens of St. Mary's County and inform the Commission for Women of the ongoing work to provide services and any gaps in the system.

We have members who serve on St. Mary's Homeless Prevention Board, the Violence, Trauma & Injury Committee, and a representative on the Maryland Legislative Agenda for Women, (MLAW), which are other areas of interest to us. The CFW members provide updates and knowledge enabling us to continue fulfilling our mission. Members of the Commission for Women are community minded women who serve throughout our county in a variety of roles. Their involvement allows us to have a broad view of current efforts, successes, and needs.

Her current position of Director of Parent and Family Engagement, in the St. Mary's County Public Schools, along with her years of experience in the teaching and education field, was a testament of the theme too.

Two former CFW Members were recognized as Hometown Heroines. Ms. Marta Kelsey and Ms. Norma Pipkin both have significant experience in education and teaching careers, with an outstanding background that ties into this year's theme. Ms. Kelsey and Ms. Pipkin delivered excellent speeches. Ms. Jane Hale Sypher spoke about the college fund and presented a check at the event. The event recognized one Tomorrow's Women and recognized eight nominees for the Woman of the Year. All nominees were recognized as true volunteers in the St. Mary's County Community. Each nominee and awardee received flowers, a gift bag of CFW items, and a plaque. Moving comments were given by several attendees. A thank you note was given to the speakers. Acknowledgement was given to our sponsors listed in our brochure. The CFW Members were thrilled with another outstanding event held to honor our community leaders and volunteers.

**October 20-Why Don't You Just Leave Panel Discussion** at the St. Mary's County Library in Lexington Park, MD. CFW Member Taylor Spencer-Davis planned this event for recognition of Domestic Violence (DV) Awareness Month. The panel members included the Southern Maryland Center for Family Advocacy staff members, law enforcement members, Family Peer Support Specialist, a licensed social worker, lawyer, and a member of the community who shared her domestic violence experience that occurred in her life for over 27 years. The question and answer session was very helpful to all. Attendees were given an opportunity to help pack bags for DV survivors. This event was opened to the public and was well attended. The Center provided literature on domestic violence and services to support survivors. An art show to spotlight local artists was also included and the winners were announced at the beginning of the program. This session was the best with reference to attendance and the CFW members were proud to say this was a huge success.
