### BOARD OF COUNTY COMMISSIONERS' MEETING

The meeting was called to order at 9:20 a.m.

### APPROVAL OF ENCUMBRANCE VOUCHERS

Commissioner Millison moved, seconded by Commissioner Arnold, to approve payment of the bills as submitted by the Director of Finance, with the exception of Voucher No. 033617. All Commissioners present voted in favor.

Commissioner Aud moved, seconded by Commissioner Arnold, to approve payment of Voucher No. 033617. Two Commissioners presented in favor, with Commissioner Millison abstaining.

# REQUEST FOR WAIVER OF PERMIT FEES PIER, BOAT LAUNCHING RAMP AT ST. INIGOES

The County Administrator presented correspondence dated October 10 from the Director of Recreation and Parks requesting a waiver of permit fees for the construction of pier and boat launching ramp at St. Inigoes.

Commissioner Arnold moved, seconded by Commissioner Aud, to grant this waiver inasmuch as it is a government agency. All Commissioners present voted in favor.

# NOTIFICATION OF GRANT AWARD COMMISSION ON AGING RETIRED SENIORS VOLUNTEER PROGRAM (RSVP)

The County Administrator presented the Notification of Grant Award in the amount of \$29,012 (Federal Share) for the Retired Seniors Volunteer Program (RSVP).

Commissioner Arnold moved, seconded by Commissioner Millison to authorize Commissioner President Aud to sign said NGA. All Commissioners present voted in favor.

### ST. MARY'S GARDEN APARTMENTS VERIFICATION OF ASSESSMENTS AND TAXATION

The County Administrator presented the Verification of Assessments and Taxation which had been prepared and recommended for approval by the Director of Finance.

The Commissioners gave their concurrence of said Verification and authorized Commissioner President Aud to sign same.

### AFLATOXINS IN CORN CROPS

Commissioner Arnold brought to the Commissioners' attention a problem that has affected local farmers. He stated that the local farmers have experienced one of the worst droughts in history which has caused a reduction in their corn crop and are now being turned away at the market because of the infestation of a fungus called aflatoxin. He stated that this has created quite a hardship on the farmers and suggested that correspondence be forwarded our U.S. Congressional Delegation requesting that loss due to the aflatoxin be included in disaster payments.

The Commissioners agreed that the County Administrator prepare such a letter for their signatures.

#### DELINQUENT MOBILE HOME FEES AND TAXES

Present: Frank Gerred, Director, Planning and Zoning

Mr. Gerred appeared before the Commissioners to request authorization for the County Attorney to commence with legal procedures to collect delinquent Mobile Home Fees and Taxes in three particular cases.

The Commissioners gave their concurrence and requested Mr. Gerred to contact the individual parties to advise them that legal proceedings will be instituted unless payment is received.

Mr. Mitchell explained that the purpose of the meeting was to obtain approval by the Commissioners for the County to enter into an agreement with the Metropolitan Commission so that they can enter into an agreement with Kiddee Consultants for the engineering of the sewage project at Tubman-Douglas. He stated that this project is 100% funded by the State.

The Commissioners agreed to authorize the Metropolitan Commission to accept Section A, Engineering Phase, of the October 3, 1980, proposal from Kidde Consultants, Inc., for a cost plus fixed fee maximum cost of administrative costs will be financed by the County through a HUD Modernization Grant.

# GROUNDWATER PERMIT REQUEST AQUAFOODS INTERNATIONAL, INC.

Notice was received from the Water Resources Administration indicating that by October 27, the County had to indicate its interest in the scheduling of a public hearing concerning permit application of Aquafoods, International, Inc., to increase their groundwater appropriation from 100,000 gallons to 275,000 gallons per day.

After discussion, the Commissioners agreed that because some citizens are concerned about the application that a public hearing should be held, and further directed that correspondence be forwarded to the Water Resources Administration requesting that a public meeting be held at the Piney Point Elementary School.
