HUMAN RELATIONS COMMISSION PROPOSAL FOR DESEGREGATION SEMINAR

On behalf of the Human Relations Commission, Father Walsh appeared before the Commissioners to advise them of the Commission's plans to organize a Social Desegregation Seminar in March of 1981. The purpose of the Seminar would be to improve awareness among the community of problem areas with regard to social segregation and to discuss possible solutions. Father Walsh went on to explain the format of the Seminar and the type of discussion that would take place. In closing, Father Walsh requested the Commissioners' endorsement of the Program in order to bring attention to the fact that it is a county-wide problem.

After discussion, the Commissioners thanked Father Walsh for his presentation, expressed their support of the Program and their appreciation for the Human Relation Commission's interest in this matter.
