### BOARD OF COUNTY COMMISSIONERS MEETING

### Tuesday, March 3, 1981

The meeting was called to order at 9:10 a.m.

#### APPROVAL OF BILLS

Commissioner Millison moved, seconded by Commissioner Aud, to approve payment of the bills as submitted by the Director of Finance. All Commissioners present voted in favor.

#### APPROVAL OF MINUTES

Commissioner Dean moved, seconded by Commissioner Aud, to approve the minutes of the Commissioners' meeting of February 17, 1981 as submitted. All Commissioners voted in favor.

### TAX CLERK POSITION - TREASURER'S OFFICE

The County Administrator presented a memorandum dated February 26, 1981 from the Personnel Officer recommending the appointment of Rose Thompson to the position of Tax Clerk, II, Grade 7, Step 2, effective March 16, 1981, to replace Mrs. Marine who will be retiring at that time.

Commissioner Dean moved, seconded by Commissioner Millison, to accept this recommendation. All Commissioners present voted in favor.

### CLERK TYPIST POSITION COUNTY ENGINEER'S OFFICE

The County Administrator presented a memorandum dated March 3, 1981 from the Personnel Office requesting authorization to begin the hiring process for the Clerk Typist (Grade 5) position which will be vacated by Rose Thompson, since the Commissioners approved her appointment as Tax Clerk in the Treasurer's Office.

Commissioner Dean moved, seconded by Commissioner Sayre, to authorize the commencement of the hiring process for the Clerk Typist position. All Commissioners present voted in favor.

### CLERK TYPIST POSITION COUNTY ADMINISTRATOR'S OFFICE

The County Administrator presented a memorandum dated February 26, 1981 from the Personnel Officer requesting authority to reclassify the Clerk-Steno, Grade 6 position in the County Administrator's Office, which has been vacant since July 8, 1980, to Clerk Typist, Grade 5, and further to approve the commencement of the hiring process for the position.

Commissioner Dean moved, seconded by Commissioner Sayre, to approve the requests as set forth above. All Commissioners voted in favor.

### NURSING HOME IMPROVEMENTS

The County Administrator presented correspondence dated January 26, 1981 from the St. Mary's Nursing Home requesting funds for certain improvements to the Nursing Home:

- 1. Replacement of 30-ton water-cooling heat exchange tower for air conditioning system \$4,596;
  - 2. Roofing Repairs \$2,850.

After discussion, Commissioner Dean moved, seconded by Commissioner Millison, to authorize the expenditures for the improvements of the Nursing Home and that the Budget Officer be directed to determine source of funds. All Commissioners present voted in favor.

#### COUNTY ROAD SYSTEM COSTS

For the Commissioners' information, the County Engineer distributed various material showing budgeted figures and actual costs for road projects in the Engineer's Office as follows:

- Expenditures of St. Mary's County County Road System for FY '81;
- 2. Budget Authorization vs. Audited Actuals for 1973-1981;
  - 3. Asphalt Overlay Account Status.

After discussion of the above, Mr. Norris indicated to the Commissioners that he had not come to a final resolution with the Finance Officer with regard to the Surface Treatment Account as he was of the opinion that there had been a double entry of a charge.

## STATE HIGHWAY ADMINISTRATION AGREEMENT URBAN NON-ATTRIBUTABLE FUNDS

Mr. Norris presented an Agreement by and between State Highway Administration and St. Mary's County pertaining to the Federal Aid Urban Non-Attributable Funds for St. Mary's County in the amount of \$9,506 for FY 1981. He stated that the only urban area in the County that would qualify was Lexington Park and that perhaps these funds could be used for the storm drainage work in that area.

Commissioner Dean moved, seconded by Commissioner Sayre, to authorize Commissioner President Aud to sign said Agreement. All Commissioners present voted in favor.

#### SURVEY WORK FOR ST. ANDREWS LANDFILL

Mr. Norris requested authorization from the Commissioners to utilize Lorenzi, Dodds and Gunnill at a maximum of \$1200 to do the survey work at St. Andrews Landfill for the expansion of that project. He stated that funds are in the project account.

### PITCH-IN-PROGRAM

Mr. Norris resumed discussion from a previous meeting concerning whether to continue to Pitch-In Program this season.

After discussion, Commissioner Aud moved, seconded by Commissioner Millison, that the Commissioners' support the program for another year; however, that stickers be placed on the Pitch-In containers stating that it is not for household trash and there would be a penalty for violators. Three Commissioners voted in favor, with Commissioner Dean voting against stating that the premise of the program was to minimize roadside litter and he was of the opinion that it did not do this. Motion carried with a vote of three to one.

### INSTITUTE FOR ENERGY SELF-RELIANCE INC. SOUTHERN MARYLAND WOOD CO-OP

The referenced representatives of the Institute for Energy Self-Reliance, Inc. appeared before the Commissioners to apprise the Commissioners of their various services to the tri-county area and to request a liason with County government.

Ms. Brown went on to explain the Institute is in receipt of a grant through the Maryland Energy Office for dissemination of information concerning energy conservation in the tri-county area. She discussed the Southern Maryland Wood Co-op Program stating that the Institute serves as an intermediary between the land owner and those people who would like to cut their own wood.

In conclusion, the Commissioners agreed to support the Wood Co-op Program and advised that the local extension office would serve as the contact point for St. Mary's County.
