### COUNTY ADMINISTRATOR ITEMS

## 1) COUNTY MAINTAINED BUILDINGS

The County Administrator distributed a list of 43 leased or owned buildings maintained by the County.

### 2) CORRESPONDENCE VACANT POSITION - HIGHWAY MAINTENANCE WORKER

The County Administrator presented correspondence addressed to Mr. Dan Ichniowski, Director, Department of Public Works responding to memorandum dated December 2, 1991 requesting to fill referenced vacancy. The response states there is not sufficient cause to allow filling the vacancy due to adverse financial impacts.

The County Commissioners agreed to sign and forward the letter.

# 3) DEPARTMENT OF SOCIAL SERVICES REQUEST TO USE UNEXPENDED FUNDS

The County Administrator presented correspondence from Ms. Ella Mae Russell requesting use of FY'91 unexpended fund balance of \$18,771.35 in the following manner:

- \$9,831,00 to fund a Child Support Agent contract position from 1/92 through 6/92.
- \$8,940.35 to apply to FY '93 budget request to continue the Child Support Agent contract position and to reduce one of the Clerk positions to one-half time in FY '93.

The County Commissioners agreed to consider this request for action at the next meeting.

## 8) PERSONNEL - AIR AMBULANCE SERVICES

In addition, Mr. Wade presented a status report on capital projects and a list of cuts from each spending unit including the Board of Education.

Commissioner Jarboe moved, seconded by Commissioner Bailey to approve the 1.8% across-the-board reduction. After discussion, motion failed 2-3.

After further review and discussion Commissioner Thompson moved, seconded by Commissioner Jarboe to proceed with the 1.8% across-the-board cuts with the exception of the following until further clarification is received. Motion carried.
