7. Wicomico Shores Golf Course

The County Administrator requested concurrence from the Board that the Standing Committee for the Wicomico Shores Golf Course be allowed to continue in the direction it is proceeding to investigate the privatization of the golf course; privatization/public operation of the golf course; or all governmental operation. He further recommended that the Committee not proceed to hire a consultant as directed in a June 11 motion by the Board of County Commissioners in that the Committee does not feel it is necessary.

The Commissioners gave their concurrence for the Committee to proceed as outlined by the County Administrator.

PROCLAMATION NATIONAL BUSINESSWOMEN'S WEEK

The Commissioners presented the referenced Proclamation designating the week of October 21 - 25, 1996 as National Businesswomen's Week.

COMMUNICATIONS FREQUENCY RESERVATIONS DISCUSSION

As a follow up to the October 8 presentation on the Communications System Study, County Administrator Kachmar recommended that the Commissioners reserve six channels. He pointed out that the consultant had recommended the County reserve ten channels at a cost of \$10,000. Mr. Kachmar indicated he would return to the Board with a Budget Amendment once the cost of the reservation was determined as he believed there were alternatives that could be investigated.

During discussion Commissioner Jarboe advised that Calvert County had recently spent \$5M on an 800 Megahertz system and requested the County Administrator to contact Calvert County to find out the benefits or problems with the system.

Commissioner Chesser moved, seconded by Commissioner Brugman, to accept the County Administrator's recommendation to reserve six channels. Motion carried four to one with Commissioner Jarboe voting against.

SYSTEMS REFORM INITIATIVE

As previously requested by the Commissioners the referenced individuals appeared before the Board to present a briefing of the purpose and activities of the Systems Reform Initiative. Ms. Fulton explained the purpose of SR, which was created by statute in 1988 to restructure the human services delivery system to families and children on an interagency basis and the five principals upon which SRI is built upon (increasing local authority; maximizing services; shifting resources to prevention and early intervention efforts; ensuring that the interagency budget reflects priorities of the Subcabinet and local management boards; and ensuring system-wide oversight, monitoring, collaboration, and accountability.

Ms. Russell reviewed the draft report prepared by the Governor's Task Force on Children, Youth, and Families Systems Reform, pointed out that the Plan is in conjunction with Welfare Reform, and that the local board will certain responsibilities. She stated that the LMB will be developing a plan of action, costs and implementation and will return to the Commissioners with recommendations. Ms. Russell advised that the Lieutenant Governor is interested in knowing whether local governments support the concept of a Joint State Commission on Children and Families (comprised of state and local governments, local management boards, child advocacy groups, and the business community); whether local governments support local planning; and whether counties are interested in receiving all of the funds at one time or step by step.

In conclusion Ms. Fulton expressed interest in maintaining ongoing communication with the Board of County Commissioners.
