Commissioner Guazzo moved, seconded by Commissioner Mattingly, to approve and authorize Commissioner Randall to sign the grant agreements for SSTAP, ADA Transportation, and New Starts Transportation. Motion carried.

Office on Aging (Gene Carter)
 Modifications to Medical Adult Day Services Budget (supplemental funding of \$13,007)

Commissioner Guazzo moved, seconded by Commissioner Mattingly, to approve and authorize Commissioner Randall to sign the grant modification and MOU for supplemental funding for Medical Adult Day Services. Motion carried.

Grant Agreement for Senior Care Program (\$19,333) and Budget Amendment.

Commissioner Anderson moved, seconded by Commissioner Mattingly, to approve and authorize Commissioner Randall to sign the Senior Care budget amendment. Motion carried.

Budget Amendment to re-allocate unused grant funds for a grant from St. Mary's Arts Council for the orchestra program (\$4,000)

Commissioner Guazzo moved, seconded by Commissioner Anderson, to approve and authorize Commissioner Randall to sign the budget amendment reallocation for St. Mary's Arts Council. Motion carried.

d) Recreation and Parks (*Phil Rollins*)
Recreational Trails Program (\$75,000 – Federal)

A community meeting will be held in late July to inform the public about the Trails project.

Commissioner Anderson moved, seconded by Commissioner Raley, to approve and authorize Commissioner Randall to approve the grant document and sign the letter of endorsement for Phase 1 of the Recreational Trails Program. Motion carried.

Access Permit for Great Mills Swimming Pool

Commissioner Guazzo moved, seconded by Commissioner Anderson, to approve and authorize Commissioner Randall to sign the access permit application. Motion carried.

e) Office of the Sheriff (Lottie Bell, Lt. Timothy K. Cameron)

Present Local Law Enforcement Block Grant Application for Federal FY 2002 and obtain authorization for the Office of the Sheriff to submit the application for grant funding and grant award on-line via the LLEBG Program Grants Management System

Commissioner Mattingly moved, seconded by Commissioner Guazzo, to approve and authorize Commissioner Randall to sign the block grant application. Motion carried.

f) Office of Community Services (Dr. Kathleen O'Brien, Cynthia Brown)) Presentation of the St. Mary's County Lexington Park-Great Mills Addiction Recovery Grant

Commissioner Mattingly moved, seconded by Commissioner Raley, to approve and authorize Commissioner Randall to sign the addiction recovery grant agreement. Motion carried.

AmeriCorps*VISTA Grant application and Memorandum of Understanding, (Cynthia Brown, Kelsey Bush)

Commissioner Raley moved, seconded by Commissioner Anderson, to approve and authorize Commissioner Randall to sign the grant application and MOU. Motion carried.

g) Maryland Department of Hygiene and Mental Health MOU Walden Sierra MOU for FY03 Operating Budget (\$2,818,454)

Commissioner Mattingly moved, seconded by Commissioner Guazzo, to approve and authorize Commissioner Randall to sign the MOU for FY03 budget. Motion carried.

Commissioner President Randall indicated to Dr. O'Brien that the Commissioners will be scheduling an agenda item to visit the Anchor (Compass) program facilities to learn more about new initiatives and how we are meeting the continuum of needs in this area.

Marcey House grant application (\$156,875)

Commissioner Anderson moved, seconded by Commissioner Guazzo, to approve and authorize Commissioner Randall to sign the renewal grant application. Motion carried.

Marcey House S.T.O.P grant FY03 (\$43,325)

Commissioner Guazzo moved, seconded by Commissioner Anderson, to approve and authorize Commissioner Randall to sign the S.T.O.P. grant application. Motion carried.

3. Budget Amendment

Finance Department (Jeannett Cudmore)

Commissioner Guazzo moved, seconded by Commissioner Mattingly, to approve and authorize Commissioner Randall to sign the budget amendment to share costs of recent bond sale. Motion carried.

Re-alignment of accounts related to compensation for three departments

Commissioner Guazzo moved, seconded by Commissioner Raley, to approve and authorize Commissioner Randall to sign the budget amendments to realign accounts. Motion carried.

 St. Mary's County Public Schools (Patricia M. Richardson, Daniel L. Carney, Dr. Fulton, and Brad Clements)
 Request approval of the St. Mary's Public Schools' FY 2003 Approved Operating and Capital Budgets.

Commissioner Guazzo moved, seconded by Commissioner Mattingly, to approve and authorize Commissioner Randall to sign the FY03 Operating and Capital budgets for SMCPS. Motion carried.

Commissioner Anderson suggested that a study group be formed to look at the results of the Thornton Commission and to develop a strategy for the future. Commissioner President Randall indicated that this would be on the Board's agenda – the first meeting to work with staff, and the second meeting to bring in legislators to help move the strategy forward.

Commissioner Raley expressed his disappointment that funding for textbooks was reduced and urged the Board of Education to continue to find additional funds for this purpose.

Commissioner President Randall stated that she was very concerned that the two nurses' salaries were not covered in the Health Department's budget as they have been in the past. These salaries should have come from the Health Department's budget for the first six months until they could be rolled over to the Board of Education. This matter was not brought before the Board by Dr. Icenhower.

Budget Amendment for FY03 George A. Forrest Tech Center.

Commissioner Mattingly moved, seconded by Commissioner Anderson, to approve and authorize Commissioner Randall to sign the FY03 budget amendment to reflect additional funding for the Tech Center. Motion carried.

 FEMA/MEMA Grant documents – Mansfield Property, Great Mills (Joyce Malone, Janet Parks)

Commissioner Anderson moved, seconded by Commissioner Raley, to approve and authorize Commissioner Randall to sign the grant documents for the Mansfield property. Motion carried.

Facilities Management (Richard Rohrbaugh)
 Move funds from various facilities management budgets to pay current electric bill (\$37,976)

Commissioner Anderson moved, seconded by Commissioner Mattingly, to approve and authorize Commissioner Randall to sign the budget amendment. Motion carried.

Commissioner Mattingly requested that the Facilities Director, Richard Rohrbaugh, review the potential benefits of installing interior, motion detector activation lights at county facilities.

 - a) Intergovernmental Agreement between the Maryland Environmental Service (MES) and St. Mary's County for the implementation of the 2002 Scrap Tire Amnesty Day Project sponsored by the MD Department of the Environment and MES. The goal of the project is to allow residents to dispose of scrap tires on a designated Saturday in either September/October 2002.

Commissioner Guazzo moved, seconded by Commissioner Raley, to approve the Intergovernmental Agreement between the Maryland Environmental Service (MES) and St. Mary's County for the implementation of the 2002 Scrap Tire Amnesty Day Project sponsored by the MD Department of the Environment and MES and to authorize Commissioner Randall to sign. Motion carried.

- b) Public Works Agreement for Greens Rest Farm Subdivision, Section 3, 2nd Election District, with a completion date of April 1, 2004. A letter of credit has been provided by County First Bank in the amount of \$161,800.
- c) Public Works Agreement for Emerald Hills Subdivision, Phases 2 and 3, 8th Election District, with a completion date of April 1, 2004. A letter of credit has been provided by County First Bank in the amount of \$175,700.
- d) Public Works Agreement for Newton Manor Subdivision, Section 1, 6th Election District, with a completion date of July 1, 2003. A bond has been provided by the Developers Surety and Indemnity Company in the amount of \$293,300.
