- b. Public Works Agreement for Greens Rest Farm Subdivision, Section 3, located in the 2nd Election District, with a completion date of September 1, 2004. A letter of credit in the amount of \$161,800 has been provided by the Community Bank of Tri-County.
- c. Public Works Agreement Addendum for Hickory Hills North Subdivision, Section 2, located in the 8th Election District, extending the expiration date to October 1, 2003. The bond in the amount of \$105,000 provided by the Travelers Casualty and Surety Company remains as posted. The original Public Works Agreement in the amount of \$458,000 was issued on August 31, 1998.
- d. Public Works Agreement Addendum for Tall Pines Subdivision, Section 1, located in the 2nd Election District, extending the expiration date to October 1, 2003. The letter of credit in the amount of \$33,600 provided by the Maryland Bank & Trust Company remains as posted. The original Public Works Agreement in the amount of \$111,000 was issued on November 18, 1999.
- e. Public Works Agreement Addendum for Arrowhead Subdivision, Section 1, located in the 8th Election District, extending the expiration date to October 1, 2003. The letter of credit in the amount of \$413,100 provided by The First National Bank of St. Mary's has been reduced to \$81,000. The original Public Works Agreement in the amount of \$413,100 was issued on October 26, 2001.

Commissioner Anderson moved, seconded by Commissioner Mattingly, to authorize Commissioner Randall to sign the public works agreements items 4.b. through 4. e. Motion carried.

Lexington Park Plan (Pathways to Schools)

To consider a supplemental appropriation in the amount of \$205,745 in State funds for the purpose of constructing sidewalks along Shangri-La and South Essex Drive.

Office on Aging (Medicaid Waiver Program)

To consider a supplemental appropriation in the amount of \$50,295 in federal funds for the Medicaid Waiver Administration and Case Management Project.

SHERIFF'S DEPARTMENT AND INFORMATION TECHNOLOGY PROJECTS

Lt. Horne and Mr. Kelly briefed the Board on the use of Palm Data Assistants (PDAs) that were purchased with block grant funds for use by the Sheriff's Office. The St. Mary's County Information Technology Department (IT) and the Sheriff's Office developed the concept of using these handheld wireless devices to record State mandated traffic stop data on specially designed software. PDAs reduce officer down time and increase communications and overall effectiveness. The PDAs also have a scaled down version of Internet Explorer, MSWord, Excel, plus connectivity and resources of County government. IT can maintain and support the units easily. Future capabilities include adding GPS, the Maryland Code, statistical analysis and access to NCIC. St. Mary's County has taken the lead in using this technology. The State is looking at it as a model project for possible replication around the State.
