SUBJECT: Complaints Against Personnel Annual Statistical Summary – 2025

Pursuant to policy, the following is a statistical summary of all complaints against personnel and their current dispositions. This summary is derived from information contained within the IAPro database from January 1<sup>st</sup>, 2025, through December 31<sup>st</sup>, 2025. The report also encompasses complaints that were initiated in 2024 but have a completion date in 2025.

The report lists all complaints against Sheriff's Office personnel to include sworn deputies, corrections officers, and professional staff. Each complaint is thoroughly investigated by either the employee's supervision for minor allegations or by the Office of Professional Responsibilities (OPR) for more serious allegations. It is important to note that on July 1, 2022, provisions of the Maryland Police Accountability Act went into effect. This included new terminology. The terminology currently utilized is defined below:

- *Administratively Charged* - the employee has been formally accused of misconduct in an administrative proceeding. This is used when a preponderance of evidence collected in the investigation showed the allegation occurred.
- *Not Administratively Charged* - a determination has been made not to administratively charge an employee with alleged misconduct. This is used when the evidence collected in the investigation failed to either prove or disprove the allegation, or due to mitigating factors, charges were not preferred.
- *Sustained (Corrections)* - the employee has been formally accused of misconduct in an administrative proceeding. This is used when a preponderance of evidence collected in the investigation showed the allegation occurred.
- *Non-Sustained (Corrections)* - a determination has been made not to administratively charge an employee with alleged misconduct. This is used when the evidence collected in the investigation failed to either prove or disprove the allegation.
- *Unfounded* - the allegations made against the employee are not supported by fact.

- *Exonerated* - the allegation made against the employee did occur, but the employee acted in accordance with the law and agency policy.
- *Merged* - when multiple violations arise from the same incident, a determination may be made that the most effective manner to address discipline in the case is to merge violations into one form of discipline
- *Formal Written Counseling (FWC)* - A form of counseling given to sworn employees who have violated an agency's policy. Formal Written Counseling, the least severe form of disciplinary action, serves as a warning for violations. A copy of the formal written counseling will be placed in the officer's disciplinary file (Excludes Corrections Officers).
- *Letter of Reprimand (LOR)* - A formal letter to an officer from the agency which details the officer's wrongful actions and states their actions have been deemed inappropriate or unacceptable. A copy of this letter will be placed in the officer's disciplinary file.
- *Loss of Leave (LOL)* - Removal of leave from officer's accrued leave total. Loss of leave shall be determined in hours.
- *Loss of Pay (LOP)* - Suspension from duty without pay. During such time, the employee's police powers will be suspended.

In 2025, two citizen complaints filed against Sheriff's Office deputies ultimately resulted in criminal charges being filed against the complainants. While such outcomes are rare, the allegations in these cases were serious in nature and were determined through investigation to be knowingly false. These unfounded claims triggered extensive criminal and administrative reviews, requiring a significant commitment of personnel time and agency resources that could otherwise have been directed toward higher-priority public safety matters. The Sheriff has emphasized that, although the agency fully supports the public's right to report concerns regarding deputy conduct, individuals who intentionally make false allegations will be held accountable and prosecuted in accordance with Maryland law.

On July 1, 2022, the State of Maryland implemented a Statewide Disciplinary Matrix. The matrix was developed by the Maryland Police Training and Standards Commission and in accordance with Md. Public Safety Code Ann. § 3-105, applies to all law enforcement officers within the state. This office, in an effort to standardize discipline throughout the agency, has applied the matrix to all Sheriff's Office employees, including Correctional Officers.
