Complaints Against Personnel Annual Statistical Summary – 2022

Pursuant to policy, the following is a statistical summary of all complaints against personnel and their current dispositions. This summary is derived from information contained within the IAPro database from January through December 2022. The report also encompasses complaints that were initiated in 2020 and 2021 and completed in 2022.

The report lists all complaints against Sheriff's Office personnel to include sworn deputies, corrections officers and professional staff. Each complaint is thoroughly investigated by either the employee's supervision for minor allegations or by the Office of Professional Responsibilities (OPR) for more serious allegations. It is important to note that on July 1, 2022 provisions of the Maryland Police Accountability Act went into effect. This included re-defining the "Findings" of complaints for sworn deputies as noted below:

- "Sustained" was changed to "Administratively Charged" meaning, the employee has been formally accused of misconduct in an administrative proceeding. This is used when a preponderance of evidence collected in the investigation showed the allegation occurred.
- "Non-Sustained" was changed to "Not Administratively Charged" meaning, a determination has been made not to administratively charge an employee with alleged misconduct. This is used when the evidence collected in the investigation failed to either prove or disprove the allegation.
- "Unfounded" remained the same, meaning, the allegation made against the employee are not supported by fact.
- "Exonerated" remained the same, meaning, the allegation made against the employee did occur but the employee acted in accordance with the law and agency policy.

The above changes do not apply to Corrections Officers as they are still governed by the Maryland Correctional Officers' Bill of Rights (COBR) under Md. Public Safety Code Ann. § 11-1001 - 1014. However, in an effort to standardize findings throughout the agency, the above changes were applied to all professional staff.
