L.I.F.E. Volunteer Driver Duties and Responsibilities

- Provide van transportation for older adults experiencing educational trips and tours using a St. Mary's County Government owned 15-passenger van.

L.I.F.E. Volunteer Driver Position Description

- Be punctual and dependable.
- Keep the Division Manager informed regularly regarding availability
- Maintain confidentiality regarding consumer information.
- Perform a safety vehicle inspection prior to departing on any scheduled trips.
- During the duration of the trip, communicate frequently with the Volunteer Trip Leader.
- Immediately report incidences, accidents, or concerns to the Division Manager following the St. Mary's County Government polices and procedures.

Skills and Qualifications

- Must possess a valid driver's license and safe driving record.
- Adhere to all traffic laws and regulations ensuring the safety of passengers.
- The ability to safely operate a 15-passenger van to transport people in and around Maryland, Virginia and Washington, D.C.
- The ability to safely navigate using GPS or navigation apps to find optimal routes to ensure timely arrival at destinations.
- Provide excellent customer service, assisting passengers with loading/unloading.
- Understand the limitations experienced by some older adults, such as mobility and hearing/vision loss.

Screening and Prerequisites

The position of Volunteer Driver requires a rigorous level of screening that corresponds to the risk associated with volunteers who work unsupervised and transport passengers in a county vehicle.

Volunteers will provide and/or complete:

- LIFE Volunteer Driver Application
- Interview
- Reference Check
- St. Mary's County Government Volunteer Driver forms, including:
 - Driver Application
 - o Criminal Background Check Consent Form
 - o MVA Sworn Statement of Affirmation
 - o Release and Waiver of Liability
 - Volunteer Health Statement
- AARP Defensive Driving Course (The course is offered at the St. Mary's County senior activity centers. The course registration fee will be covered by the Department of Aging & Human Services.)
- L.I.F.E. Volunteer Driver training and regular periodic training as needed.
