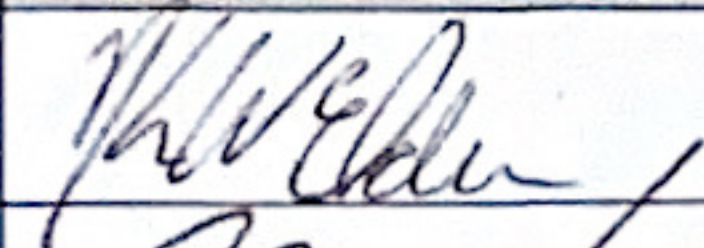
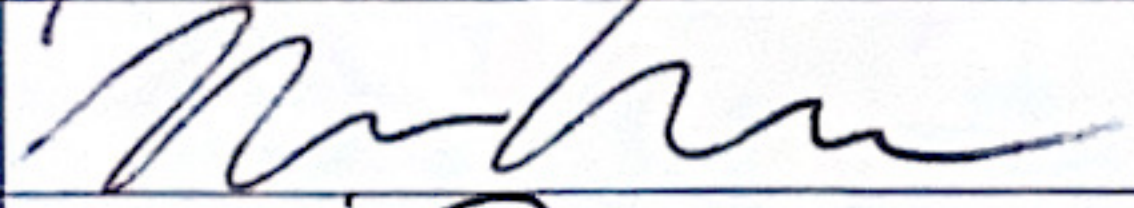
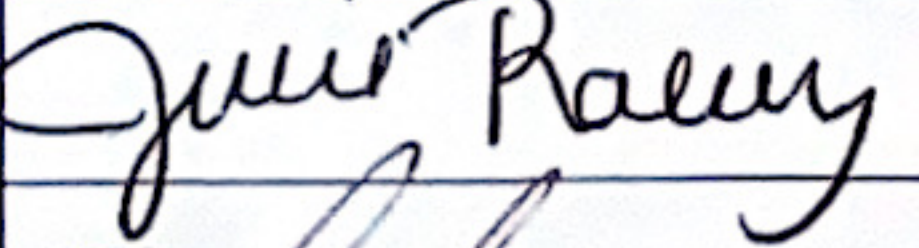
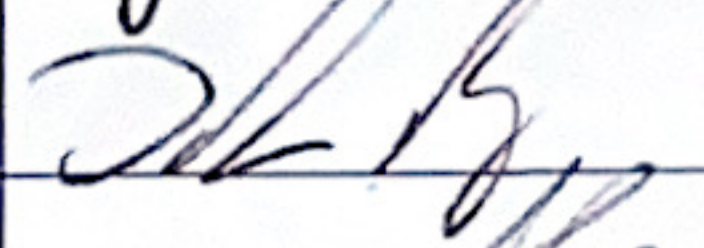
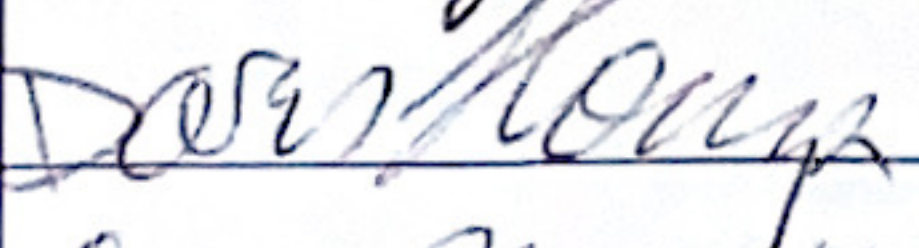
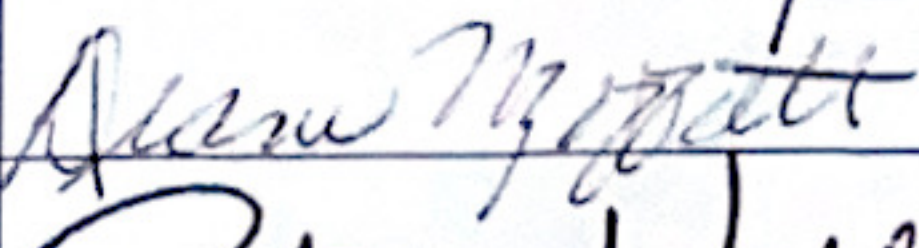
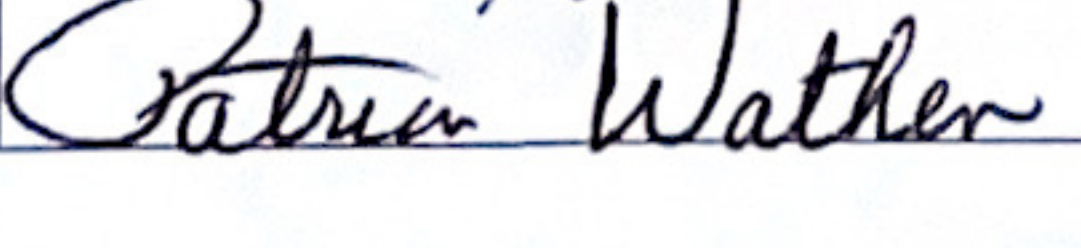


Petition to Oppose the Concept Site Plan (#20-13200011) for a Farm Brewery located at 40140 Wathen Road

Petition summary and background	Concept Site Plan #20-13200011, Breton Bay Brewery – Zoning Ordinance 10-02 using #12C Farm Brewery Using #12C Farm Brewery will require the Owners, David and Jada Stuckert, to hold a Class 8 Brewery License. This license allows for on-site consumption of the beer, not just sale. Anyone with a Class 8 farm brewery license may also sell and deliver beer from the farm brewery to a wholesale company or directly to an individual consumer. The license allows owners to operate 7 days per week and to host events (including multi-brewery events) at their location. The opening of a Farm Brewery on Wathen Road would cause increased traffic on Wathen Road. The sales and consumption of alcohol on the property also poses a safety threat for our neighborhood.
