**St. Mary's County COVID-19 Pandemic**  
**Roadmap to Recovery**  
**June 23, 2021**

**BACKGROUND**

*Maryland's Roadmap to Recovery* was released by Governor Lawrence Hogan on Friday, April 24, 2020 which outlines how the state plans to reopen after the COVID-19 pandemic. The four building blocks of the Roadmap to Recovery include (1) procuring Personal Protective Equipment (PPE) for healthcare workers; (2) generating hospital surge capacity; (3) having adequate testing capability; and (4) a robust tracing program.

The Governor's building blocks are consistent with the recovery efforts within the White House Coronavirus Task Force's *Guidelines for Opening Up America Again*.

The Governor's roadmap is not a calendar, or a set of fixed dates, but rather an important guide to show the intended path forward to recovery. The Roadmap is divided into Low Risk, Medium Risk and High Risk Stages for recovery; each stage may contain multiple phases.

While there is local flexibility in recovery decision-making, this should be within the parameters set forth by the Governor and his Administration for each stage and particular sub-phase. The St. Mary's County Health Officer and St. Mary's County Board of Health will work as needed with key community partners in local decision-making based on pandemic characteristics affecting the county and region.

**IMPLEMENTATION**

Telework, Face Coverings, And Physical Distancing should continue throughout the different stages of recovery.

- 1) Employers and Employees should support and encourage telework plans;
- 2) Residents should continue to wear face coverings or masks in public places where they are exposed to others;
- 3) Residents should continue to practice physical distancing of at least six feet;
- 4.) Maryland Health Department amended the testing requirements for travelers to advisory guidance. Residents should not engage in non-essential travel.

**DATA INFORMING LOCAL DECISION-MAKING**

The below data, as available, will be monitored by public health officials and reviewed, as allowable by federal and state confidentiality laws, with the St. Mary's County Board of Health to assist with local decision-making. Sharing of data with the general public is subject to federal and state confidentiality laws, state executive orders, and review by the Maryland State Attorney General's Office.

- (7) Local inpatient bed and intensive care bed capacity
- (8) PPE supply availability for long-term needs of local health care workers, first responders, and law enforcement
- (9) Local availability of COVID-19 testing supplies and laboratory capacity to process these tests
- (10) Hospital surge models or projections impacting St. Mary’s County

**Regional Metrics**

To the extent possible, regional data for Southern Maryland will be monitored by local health officials. Such data may more comprehensively predict risk for St. Mary’s County residents given the mobility of residents across county lines in Southern Maryland when stay-at-home orders are not in effect or when essential workers traverse county lines.

- (9) Regional availability of COVID-19 testing supplies and laboratory capacity to process these tests
- (10) Regional hospital surge models or projections

**MARYLAND:** Governor Hogan entered a “pre-stage” - easing outdoor restrictions on golf, horseback riding, hiking, tennis, parks, playgrounds, recreational boating, and hunting. Automatic car washes permitted.

**ST. MARY’S COUNTY:** Recreation & Parks re-opened waterfront parks and boat ramps/public landings, 8 playgrounds, and the Wicomico Shores Golf Course.

**MARYLAND:** Governor Hogan announced that Maryland is moving to the initial recovery stage on May 13, 2020 - Lifting the Governor’s “Stay at Home” Order & moving to a Safer-At-Home public health advisory on May 15, 2020 @ 5 PM. Opening small shops and certain small businesses (retail stores 50% capacity); curbside pick-up and drop-off for businesses encouraged; encourage outdoor religious activities; outdoor work and appropriate distancing measures; some personal services - barber shops & beauty salons for hair, only (50% capacity & by appt. only); retail establishments (50% capacity). Manufacturing businesses and facilities may open.

**ST. MARY’S COUNTY:** The Department of Economic Development is working with applicable businesses to re-open under the Governor’s Stage 1 Roadmap to Recovery.

**MARYLAND:** On May 27<sup>th</sup>, Governor Hogan announced that Maryland is completing Stage 1 easing additional restrictions effective May 29<sup>th</sup> @ 5 PM for certain food service establishments to serve food and beverages in outdoor seating areas in addition to carry-out, drive-thru and/or delivery; increased public spaces open and outdoor recreational activities.

**ST. MARY'S COUNTY:** The St. Mary's County Health Department and Department of Economic Development are working with the restaurant establishments and applicable outdoor recreational establishments to re-open safely. The Department of Recreation & Parks is re-opening public spaces and increasing outdoor recreational opportunities in accordance with the Governor's Executive Order.

**MARYLAND:** On September 1, Governor Hogan announced that Maryland will enter Stage #3 of the Roadmap to Recovery on September 4, 2020 at 5:00 p.m., opening Other Recreational Establishments and Shopping Centers; increasing Retail Establishments and Religious Facilities Capacity to 75%. Beginning August 31<sup>st</sup>, Governor Hogan announced Maryland schools were safe to open following safety guidelines.

**ST. MARY'S COUNTY:** St. Mary's County Government administrative buildings will open to the public, accepting walk-in customers. SMCG is working with businesses and the community to expand re-opening efforts under Governor Hogan's Maryland Strong Roadmap to Recovery.

Telework mandatory for eligible state employees. Maryland Department of Health issued two (2) Public Health Advisories for travel and avoiding indoor gatherings of 25 people or more.

Exempt states are Delaware, Virginia, West Virginia and DC. Public Health Advisory reduced public gatherings to 10 people or less.

**MARYLAND:** On February 23, 2021, Governor Hogan issued an Executive Order restating previous order, regulating certain businesses and facilities and generally requiring use of face coverings. A travel advisory to refrain from non-essential travel is in effect. If resident engages in out-of-state travel, they must take a COVID 19 test upon re-entry and quarantine until a negative test result or 10 days. Public Health Advisory for public gatherings is 10 people or less.

**END OF STATE OF EMERGENCY.** Effective July 1, all emergency mandates and restrictions will be terminated. There will no longer be any statewide mask order in effect for any settings, including schools, camps, and childcare facilities.

**ADMINISTRATIVE GRACE PERIOD.** Effective July 1, a 45-day grace period will begin where certain regulations will continue to be relaxed to complete the administrative transition out of the pandemic. This includes such provisions as renewing driver's licenses, winding down emergency health operations, and the moratorium on evictions related to COVID-19.

## ST. MARY'S COUNTY:

Effective July 1, 2021 the local State of Emergency in St. Mary's County is rescinded.
