**Background**

On the 17<sup>th</sup> Day of December 2013, St. Mary's County Government adopted an ongoing Transportation Advisory Committee to serve in an advisory capacity for planning service and policy changes to St. Mary's Transit Systems services. The committee includes representatives of human service agencies, municipal and county government, private transportation providers, the business community, current customers, and the community at large, including individuals with disabilities.

The Transportation Advisory Committee will provide the Commissioners of St. Mary's County with transit-related information and assistance concerning public transportation with respect to preparation of the St. Mary's County Transit Development Plan, Planning of service and policy changes for Locally Operated Transit Systems, and coordination among specialized transportation providers. This Committee also serves as advocates for the community regarding public transportation.

## **Committee Activities**

The Transportation Advisory Committee (TAC) is committed to fulfilling its Public Activity functions, per the Committee Bylaws. TAC activities for CY25 fall under each of the four functions.

**Functions 1 and 2 - Preparation of the St. Mary's County Transit Development Plan, and Planning of service and policy changes for Locally Operated Transit Systems:** Members of the Transportation Advisory Committee participated in a planning strategy prioritization for the upcoming Southern Maryland Coordinated Transportation Plan. Project statuses of the Countywide Transportation plan were also shared with the Committee in the first meetings of the year.

**Function 3 - Coordination among specialized transportation providers:** Progress and updates to the STS mobile app were shared with the Committee. TAC members downloaded and reviewed the app, sharing comments and suggestions. Members also received news of planned updates and were informed of key technological features powering the app.

**Function 4 - Advocacy for the community regarding public transportation:** The Committee has kept abreast of efforts by the St. Mary's NAACP to bring affordable Driver's Education to St. Mary's County Students.

## **Accomplishments**

The TAC continues to add citizen members to its roster, and has added institutional representation from St. Mary's College, and NAS Pax. The Committee will enter CY26 with nominees for all three leadership positions.

## **Problems and Challenges Encountered**

There remain three Ex Officio positions open on the Committee. TAC will seek to fill these positions in order to maximize community impact through collaboration with our institutional partners.

## **Future Plans**

The TAC remains ready to advise and participate in development of the Southern Maryland Coordinated Transportation Plan, wherever and however appropriate. The committee will continue to fulfill Article III of the *Bylaws of the Transportation Advisory Committee of St Mary's County*. TAC will continue to foster relationships with community and institutional partners, participate in project planning, and build on the momentum of our past accomplishments.
