## HISTORIC ST. MARY'S CITY

Cooperative Wildlife Management Area. Approximately 180 acres open to Deer Hunting only. Permit and Daily Reservation Required.

## SALEM STATE FOREST

Approximately 1702 acres of undeveloped land on Indian Bridge Road (includes former Walton Lumber properties). Open for all legal species in all seasons

## NEWTOWNE NECK STATE PARK

301-743-5161

Approximately 500 acres open to hunting for all legal species in all seasons. Fields and riparian blind sites are available for waterfowl hunting. Permit and daily reservation required for all

## ST. MARY'S RIVER STATE PARK

301-872-5688

Site 2 covers approximately 2,200 acres and is primarily undeveloped and is a State Wildlands Area and Managed Hunting Area. Open for all legal species in all seasons.

Three blind sites open for waterfowl. Permit and reservation required; gasoline motors prohibited.
