# Waterfront Park Reminders

It is unlawful to consume alcoholic beverages in County Parks.

All types of containers entering the Park are subject to random checks by staff.

Vaping and tobacco products are prohibited in County Parks.

If you leave the Park, you may not re-enter without paying again.

Glass bottles and glass containers are not allowed.

Please dispose of all trash and refuse in receptacles.

No lifeguards are on duty at any Waterfront Park. Park usage is at your own risk. Medical insurance is not provided.

Once the Park capacity is reached additional patrons may not enter until others leave the Park.

The seasonal fee covers the cost of one pass. Additional cars and/or lost passes will require the purchase of additional passes.

Entrance to the Waterfront Parks is through the main entrance. No one may enter the Park Beach from the waterway unless they have a season pass for the Park they are entering.

Pets must be on a leash at all times unless they are in the water. Handlers are responsible for their pet's behavior and also must clean up after their pet.

When Park grills are used, please extinguish all charcoal fires before leaving. Visitors may bring their own personal gas grill (propane bottles not exceeding 2.5 lbs) to the Park however; Personal Charcoal Grills are Not Permitted. Absolutely No Open Campfires.

Unregistered vehicles and ATV's are prohibited.

If using a metal detector there is no digging allowed in the Parks. If an item is found above ground, patrons may pick it up.

No hunting or overnight camping on any lands managed or leased by the Rec. & Parks Department unless specifically authorized.

Additional amenities (i.e., balloon bounce, water slides, dunking booths, etc.) are not allowed in the Park without prior written approval from Recreation & Parks.
