# Violation

**Lex Wine & Spirits** - Roland Mellies - Commission of acts on licensed premises contrary to State law in violation of Section 5.04(b) "Acts Contrary to Law" of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County; to wit: Distribution of Tobacco Product or Paraphernalia to Minor in violation of Section 10-107 of the Criminal Law Section of the Maryland Annotated Code.

Roland Mellies appeared before the Board and was sworn in. Mr. Mellies stated that the violation did occur. Vice chair Watts stated that this is the second time the licensee has come before the Board in 5 months. Vice chair Watts asked Mr. Mellies what changes he has implemented after the first violation. Mr. Mellies stated that he has put 100% ID checking of all patrons into place, put in software POS system which prompts clerks to ask for ID. Chairman Willenborg stated that this is the businesses second time before the Board, but it is their third violation. Chairman Willenborg asked Mr. Mellies if he understands that he could revoke his license. Mr. Mellies acknowledges and understands and respects the severity of these charges. Vice chair Watts reminds Mr. Mellies that he had \$1250.00 in fines held in abeyance from his previous violation and that those fines will have to be paid as well as what other penalties they impose today. Vice chair Watts made a motion for a \$1000.00 fine, along with the \$1250.00 from the previous fines. Member Hill seconded the motion; motion carried. During discussion Chairman Willenborg stated he would have preferred \$750.00 2:1 Willenborg opposed
