Ms. Taylor Staley waived her right to appear before the Board. Attorney Beaver read the facts into the record. Vice Chair Watts made a motion for a fine of \$500, seconded by Member Hill; motion carried.

 - Commission of acts on licensed premises contrary to State law in violation of Section 5.04(b) "Acts Contrary to Law" of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County; to wit: Distribution of Tobacco Product or Paraphernalia to Minor in violation of Section 10-107 of the Criminal Law Section of the Maryland Annotated Code.

Mr. Frinso Padavil and Ms. Amanda Shirley appeared before the board and were sworn in. Mr. Padavil admitted that the violation did occur. Attorney Beaver read the facts into the record. Mr. Padavil stated that the clerk who made the underage sale thought she recognized the informant and that is the reason why she did not ask for an ID. Vice Chair Watts made a motion for a fine of \$500, seconded by Member Hill; motion carried.

 - Application for Johnathan M. Arakelian to purchase a Class B (Restaurant) BWL license & t/a Smash House (Smash House, LLC), 41656 Fenwick St., Leonardtown, MD 20650. And permission for extension of premises for outdoor seating.

Johnathan Arakelian appeared before the Board and was sworn in. Mr. Arakelian currently has an existing business and is moving to a new location. Chairman Willenborg

asked Mr. Arakelian if he had ever been found guilty of any charges. Mr. Arakelian admitted that he was found guilty of serving a minor 3 years ago at a different establishment. Mr. Arakelian stated that he would have 100% ID checks and training sessions for all new employees at his new establishment. Board expressed concerns over the outdoor seating area and the cooler location outside of the establishment. Mr. Arakelian was not sure if the cooler would have an interior door and did not know if it would be approved. Vice Chair Watts made a motion of a 90-day conditional approval, pending the approval from the Health Department, Fire Marshal, U&O and an updated business license and finalized drawing, seconded by Member Hill; motion carried.
