Letter from State Raods Commission, requesting the Boards opinion as to the desirability of constructing a mile of road ~~####~~ starting at a point on the Beauvue - Valley Lee ^{roads} where the State Road from Hobb's Store towards Beauvue is now completed, and running thence over the old County Road to the intersection of the Leonardtown-Point Lookout Road, in preference to building the gap now existing in the Beauvue- Valley Lee Road, was read.

Clerk directed to write the State Roads Commission, recommending the construction of the gap now in the ValleyLee - Beauvue Road.
