This charge is for the material used, and the labor cost to be paid by the Government. The County Commissioners approved the installation of the toilets.

The Board refused to pay the bill of the Md. Tuberculosis Sanitorium for the burial of Geo. A. Brooks in the amount of \$25.00

In the matter of Major Davidson request for reduction of assessment of his Cremona Property, upon recommendation of Mr. Adams the Board approved a reduction of \$5,850.00.

The Board directed the Clerk to advise Mrs. F. L. Matthews, of the Welfare Board, that no further additions to Old Age Pension Payroll would be approved.
