Minutes of last meeting read and adopted.

Estimate and Bid of Ben. Owens for repairs to Alms House in the amount of \$121.00 for labor and material accepted by the Board, and work authorized to be done.

The Clerk was directed to write th e State Roads Commission, urging the completion of the Three Nothch Road.

Mr. Stephen Jones of the County Trust Co of Maryland, advised the Board , the County Trust Company of Md. would lend the County Commissioners of St. Mary's County, \$11,000.00 for the construction of the Great Mills School, the loan to be secured by a 122months note , to bear interest at 4% per annum, with the privilege of renewing the note <sup>4 or 5</sup> each provided a curtailment of at least \$1,100.00 is made each year, and provided futher no unforeseen financial conditions warrant the termination of this loan. (The above loan of \$11,000.00 to be used on W.P.A. Project at Great Mills.)

After securing this information from Mr. Jones, the following resolution was passed unanimously, and the note for \$11,000.00 was executed.

Resolution-

By virtue of authority contained in Chapter 30 of the Acts of the General Assembly of Maryland, passed at the Special Scession of 1933, and in conformith with the within resolution, the Board of County Commissioners of St. Mary's County Maryland, have gegotoated a loan from the County Trust Company of Maryland, a body corporate, from its Leonardtown Maryland Branch, in thē amount of \$11,000.00, with interest at the rate of 4% per annum, the said County Commissioners having entered into a contract for a grant of money in aid of construction of a W.ub.Pic.A.Sc.Project, ~~with a Federal Agency~~ (atop'wito. Md. the construction of a Public School House at Great Mills, St. Mary's Co. Maryland.), it is hereby certified and recited that each and every act, condition and thing required to exist, <sup>2</sup>to be done, to have happened, and t to be performed, precedent to and in the issuance off this note, does exist, has been done, has happened and has been performed, in full and entire compliance with the Constitution and laws of the State of Maryland and the resolution of said County Commissioners of St. Mary's County Maryland, and that the issuance of this note together with all other indeptedness of St. Mary's County Maryland is within every debt and other limit prescribed by the Constitution of the said State.
