Minutes of preceding meeting read and approved.

Taking up a letter from the Farm Security Administration, wherein it is requested that the County ~~supply~~ provide an office for the Farm Security Admin. special project, at Ridge, Md. The Board decided that it had no funds available for this office, and directed the Clerk to so advise the State Director of the Farm Security Admin.

Mr Jos. P. Wilkinson, Depty. Treas. appeared before the Board and requested that some action be taken towards enforcing the payment of six years back taxes on the Geo. R. Williams property, 5th Dist., since the Treas. had no funds with which he could employ an Attorney. The amount of back taxes being \$274.77, Mr Wilkinson stated the property was sold by Jno. H. T. Briscoe, Trustee, Mr. Wilkinson stated that he had made several requests to the Trustee for payment and the Trustee had always promised to pay but each time he had neglected to do so. The Board invited Mr. Briscoe to come before the Board, which he did, and promised to pay the amount due at once. The Board took no further action in the matter at this time.

The board fixed the Salary of the Substitute Trial Magistrate and Clerk to the Trial Mag. Court at \$600.00 per year for both jobs combined, effective as of June, 1, 1941.

The Board fixed the Salary of Mace Birch, J.P., 1st Dist. at \$75.00 per year, effective from the first Monday in May, 1941

Messrs Donavan Bohannon, E. A. Norris, Miller Tippet, John Briscoe and Stephen Bodnor asked the Board to have the road from Park Hall to the 3 Notch State Road, about 1 mile, 8th Dist. surfaced with oil. the Board decided it would have no funds to do this now but would consider the treatment of the road with calcium carbide to keep down dust. Mr. Thompson asked to report.

The Clerk was instructed to write the State Roads Com. and recommend that the Trossback road, about .6 mile, 1st Dist. be accepted into the County road system for maintenance only.
