

March 13, 1951
Regular meeting.

The Board met today, with all members and their attorney present Mrs. Ann Fowler acted as secretary in the absence of the clerk who was ill.

Minutes of previous meeting were read and approved.

Mr. Carey Lacey, Supt. of High Schools requested permission to use some of the old bookshelves which had been removed from the library. Permission was granted and the shelves were placed in the Grand Jury room.

Fr. M.C. Kavanaugh, S.J., asked for a road in the new development on the Oraville road- the "St. Joseph Welfare Club" settlement. The Club will give 50' wide Right of Way. Board agreed to accept the road, when proper steps have been taken and DEED for Right of Way is made to the Commissioners. They will advise Mr Thompson of their action in this matter.

Mr. J.J. Johnson, County Agent asked for appointment on March 20 and suggested that Mr. Bradford Reeves be present for full time Assistant County Agent.

Comm. Downes, Tall Timbers, asked about progress on Erosion Project at Tall Timbers. He was advised that the survey is not yet completed and is expected by the next meeting- March 27.

Bennie Ownes presented bill for work in Law Library and jail. Made and installed shelves in Law Library and placed complete window in jail. This was presented in 2 separate bills, as the library bill was separate from the rest of the work around the Court House.

Road. 1st Dist. Mr. Leon Dunbar- Cornfield Harbor asked for road. Mr. Thompson and Mr. Stone will inspect this and report at the next meeting.

Mr. Lloyd Dean appeared for Dallas Hayes and asked for 1 mi of road at Hayes Beach running to bay shore be repaired. Mr. Stone and Mr. Thompson will inspect this also and make report.

Public Landings. Mr. Frank Bailey reported that the Board of which he was a member had worked on the matter of having all Public Landings surveyed and staked out plainly. Cement stobs have been made but never installed. Mr. Thompson had agreed to make the surveys but nothing had been done. Mr. Briscoe was also present and verified Mr. Bailey's statements. Mr. Gay said they have already gone into the matter somewhat.

Mr. Frank Bailey again asked what had been done about hiring help to get out the Tax bills.

Mr. Cleve Bailey wants an open road from Blue Stone Ridge to State Rd in White's neck. Said it had been promised but not done. Mr. Thompson came in and this was discussed.

Outpatient- Dr. Alan D. Houser explained about the State appropriation of \$1740. Dr. Houser requested a meeting with the Commissioners as Board of Health at their next meeting Mar. 20-1 p.m. A special meeting is set for this matter.

Jail. Shrf. Willard B. Long appeared about a sick room at the jail. Said Governor Holmes was refused admission at Spring Grove as they had no commitment papers.

Mr. Guy checked the mattresses in the jail with the sheriff and asked that States Atty. Jos. Mattingly have the drunk room in the jail cleaned up- remove oyster scrapers etc.

Mr. Thompson reported that Mrs. L.L. Cobb wanted the Fr. White marker moved.

Mr. Rip Tennyson wants an outlet for a new tenant house he has built.

Thallie Norris- 7th Dist. requested that the Board have a piece of pipe placed on his property to drain it and drain the entrance. Mr. Thompson and Mr. Guy will inspect this and report

Mr. Bowman and Mr. Nicolet came in to discuss a seawall and survey, same as Comdr. Downs discussed.

Conference with Dr. Houser and Mr. Tilp, re new Health Clinic and County Building. Same will cost approx. \$110,000.00 if made according to plans Board desires, as same runs about \$1.00 per cubic ft. Basement estimate is \$3,000.00 Building to be cinder block, brick face, flat roof "A" shape, 2 story building. Mr. Tilp will report on progress he makes with drawings.

Commissioners decided the minutes of Dec 12 should be in two sections, one for the former Board to sign which adjourned at noon. The other to be the first part of the new Board's work, which Mr. Alvey will sign.

Board inspected the work in the Law Library and adjourned at 4 p.m.
