

December 11, 1956

Board met in regular session today with all members and their attorney present.

Members of the Vol Fire Depts- Lex. Park, McKay's Beach, Mech, and the 7th, appeared concerning a Special Tax to be levied to help defray operating expenses of the various departments. Annual carnivals and donations do not take care of all expenses, which include payment of notes and purchase of new equipment. All Vol Fire Depts have not asked for this- but all companies desire to have members trained which costs. Led. Pk needs \$5,500 for new equipment; McKay's Beach needs \$5,000. This would require special legislation and would refer to only those Districts where the companies needing the extra money are located. A Referendum would be necessary which would cost the County about \$5,000. In the event such a law was enacted the County would not have to make the annual allotment of \$700 for each company as they now do.

Health Dept Budget- Mr. Ganes came down from Baltimore to explain the 1957-58 Budget for the County Health Dept., increase in salary of sanitarians was explained and in order to have State money matching County money it is necessary that all sanitarians be placed on a level as set by law. Beginning Jan 1957 every 6 weeks a Mental Hygiene Clinic will be held in this County. Dr Houser had asked that the position of Nurse-Obstetrician be placed in the Budget but there is no one in the Health Dept at this time who can qualify so the position was dropped. New Budget will be sent in early in 1957 for approval and it will not exceed \$100,000.00. Until July 1957 we pay for films etc., for the Health Dept County Tax Rate set at \$1.50 per \$100. Tall Timbers EPP set at \$2.50 per \$100. Court House Building Committee to consider Air conditioning, it was decided to request bids and make decision later as well as decisions on landscaping- alternats allowed for air conditioning were approx \$46,000 and for landscaping approx \$16,000

Mr. Tilp asked for color scheme for the rooms and halls, as well as decision as to where County Seal should be placed.

Board adjourned after long discussion with Miss Dent about schools, new and additions thereto-she wants the Bd to borrow \$84,000 from School State Loan. Loan will not be needed until Spring 1957, Bd asked for a breakdown for this money.
