J. Douglas Bond, County Res. Engr. came to talk about roads that should be included in the Federal Aid Secondary Rds system- those already in this system are

4 Mechanicsville to Chaptico 5 Willows Rd

Letter written to State Roads Commission notifying them the Blair-Reeves Rd had been accepted for maintenance.

Kenneth B. Duke inquired about his salary as Clerk to the Bd. of Election Supervisors- effective November 1, 1959 it was increased from \$250. to \$500 per yr

At 2 pm Messrs. Duncan, Gleason and Bond came in to talk about planning for roads to be placed in the Federal Aid Secondary system. They brought maps on which the Commissioners are asked to outline in color the roads they desire included in this system, and suggested such roads be planned 5 yrs in advance of expected building.

In the matter of the extra current Mr. Lee Willson is requesting for the lights in the old Lexington Park Shopping area- Rt 235 to Coral Pl on Tulagi Dr. 4 lights would cost an additional \$17.34 per month. No decision.
