# Committee for Citizens in Violation of Trailer Regulations

Rev. Stone and the Committee members requested to see the Commissioners in order to express their concern for the persons who have received warrants due to the fact that their trailers are in violation of Trailer Regulations, and the deadline is Friday, March 31st.

Mrs. Gloria Morgan, one of those in violation, stated that the trailer belongs to her brother, who lives in it, and it is situated on her property. Most trailer parks are filled and where there are spaces, the spaces are not large enough. She was very concerned about the fine of \$25 to \$100 per day, and asked "What do you do when you are unable to pay for installation of water and a septic system, how can you pay that type of a fine?" She also stated that she was attempting to put water in her home and was stopped due to the trailer being on some one else's property.

Mr. Jonathan Nelson was also very concerned in the same areas and stated that some avenues should be opened up in order to assist these people. He and Mrs. Morgan feel many avenues are closed.

The Commissioners reassured them that Mr. Thomas Cryer, County Inspector has been informed not to take anyone to Court until he has submitted each individual case to the County Commissioners for review. The Commissioners also stated that there should be some type of legislation requiring the trailer dealer to include financing for sewer and water facilities in the financing for the trailer. The Commissioners also informed the group that they might possibly get emergency legislation through this session of the General Assembly for this type of thing and suggested that

they contact the two Delegates and the Senator, in Annapolis. There is a possibility that it might be done, even though the deadline date of March 6, 1972 is past for accepting new legislation, or they might have a bill in that could be amended. It was felt that if this was done, perhaps the lending institutions would take a more favorable look at it. The Commissioners assured the group that they would lend their support to a petition and resolution.

#### Dollars for Scholars

The Board of County Commissioners presented Miss Eloise Pickerell, Chairman of the Citizen's Scholarship Foundation with a Resolution recognizing the week of April 3-10, 1972 as "Dollars for Scholars" week, and that the month of April be designated as their campaign month.

## Damage Claim - Fedders' Property

Mr. August H. Wagener, County Engineer, reported that he had inspected the Fedders' property and affirmed the fact that some damage had been done. Spoils from the dredging in St. Jerome's Creek had been placed in the pond, which pond had been used for drainage purposes for the property. The Commissioners requested Mr. Wigginton to review the agreement signed by the Commissioners and contact the attorney for the Corps of Engineers to determine the liability of the County.

# Confiscated Cars

Mr. Robert E. Wigginton, County Attorney, informed the County Commissioners that he would have to file the necessary papers in order to have the cars of Messrs. William F. Yowaski, James matthew Wood and William Charles Thompson released. The Commissioners voted unanimously to release the cars of Messrs. Yowaski and Wood.

Mr. Wigginton was instructed to inform Mr. Thompson that he will have to pay the County for storage before he may recieve his car.

The Commissioners stated that they do not want to use any of the confiscated cars for the County. On all family cars that have been forfeited and were driven by children of the owners, after the payment of any fine and costs, the cars will be returned to the owners. They agreed that where the pusher of drugs is the owner of the car, each case will be reviewed by the Commissioners. Mr. Wigginton was also requested to look into the case of Ronald Michael Kenny and the Volkswagon Bus he was driving.

#### Health Benefits Insurance Plan

Mr. B. Harris Sterling, Director of Finance, stated that the Health Benefit Insurance Plan is \$5,000 coverage for hospital services, room and board for fifty (50) days. The maximum payment is \$50,000, and if the policy is converted, the \$50,000 major medical benefit is omitted. He further stated the problem came up with discretion of employees whose spouses are employed either by the State or Federal governments, and whose plans are different. It was, therefore, recommended by the insurance company that the County pay 75% and the employee pay 25%.

He further stated that Massachusetts General was not taken due to the increase in rates after February 15, 1972. Blue Cross-Blue Shield did come up with a program, but it was \$8.00 higher.

The Board of County Commissioners unanimously voted to accept The Prudential Insurance Company of America's Plan for the employees, provided the employees registered 75% for this Plan.

# Salary Increases for Clerks in Treasurer's Office

The three (3) Job Descriptions for the Clerks in the Treasurer's Office were brought to the attention of the Commissioners. They stated they were still of the opinion that there was not an increase in the duties of these employees; that perhaps the workload had increased, therefore, they would withhold any decision on this matter pending any raise the State employees might receive.

# Approval of Medical Scholarship

The Board of County Commissioners approved the Medical Scholarship in the amount of \$2,500 per year for Mr. Richard Arthur Bean, pending approval by the Director of Finance.

Mr. J. S. Guy, Jr. reported that Mr. Rip Tennyson wishes to farm Clements Landfill property, if it could be leased. It was agreed to find out what a suitable lease would be.
