All Saints Church would like to

establish a Head Start preschool program in an existing structure at 21656 Oakley Road. The Property is zoned Rural Preservation District ("RPD") and lies fully within the Resource Conservation Area ("RCA") Overlay District. Current zoning regulations allow a program such as Head Start in the RPD, but not in the RCA.
