## PRESENTATIONS:

Barbara O'Neal presented a roll up and raw data from the 2025 Point in Time Count of Southern Maryland as of Jan 22, 2025. This data is
available at Maryland Balance of State Continuum of Care https://www.mdboscoc.org/pit-count Barbara stated that St Mary's numbers reported
are not accurate. The people in the Wrapping Arms 'Round Many (WARM) program were not counted because they were temporarily sheltered in
the winter. Others temporarily housed in HUD funded programs, like Lifestyles, also not counted. This was realized after the fact and was
accidental. We have no Emergency Shelters in St Mary's county. This is important because there are a number of people 55 and over who go to
the WARM shelter every winter. Also this is to show there is a real problem of homelessness in St Mary's County.
