a. Any road improvement (s) required by the state and county must be concurrent with the issuance of the Certificate of Occupancy.

b. Obtain Variances from the Board of Appeals from the following requirements:

1) CZO Section 51.3.96.a.(3).(b): New facilities shall be horizontally located 1,500 feet from the nearest home or institutional building. The facility is 1,000 feet from the nearest home. To reduce the required 1,500 feet to 1,000 feet.

2) CZO Section 51.3.96.a.(7): Solid waste or resource recovery facilities shall have a commercial entrance and be located on a road with a designated major collector or higher classification. The facility is located on Carpenter Lane which is classified as a minor collector. To allow the facility to be located off a minor collector.

c. Obtain permission from the Commissioners of St. Mary's County to create site access from the Commissioners' Right-of-Way.

d. Signage for tractor trailers to turn right only, when leaving the site.

e. Conditional approval of the Traffic Impact Study and Adequate Public Facilities
