LEONARDTOWN, MD – The Commissioners of St. Mary's County (CSMC) began their [business meeting](#) with an invocation and the pledge, followed by approval of the consent agenda.

The CSMC then presented proclamations in recognition of [LGBTQIA Month](#) and [National Homeownership Month](#), followed by a special [recognition ceremony](#) for St. Mary's County Government (SMCG) employees with 10 or more years of service. The Commissioners then received a [Board of Health briefing](#) from Dr. Meena Brewster, St. Mary's County Health Officer.

The CSMC then held a [public hearing](#) on proposed amendments to St. Mary's County Code, Chapter 203, "Building Construction" and Chapter 223, "Inspection Fees."

During County Administrator Time, the Commissioners took the following action:

- [Reviewed](#) future CSMC meeting agendas.
- [Approved](#) the construction of a new well located near the Wicomico Shores Golf Course.
- [Approved](#) the use of \$240,000 in federal funds to improve sidewalks along Pegg Road.
- [Approved](#) the continuation of the noxious weed agreement for the control and eradication of invasive and designated weed species in St. Mary's County.
- [Approved](#) using \$100,000 from the Commissioner Emergency Reserve for payment of the FY2024 4th quarter LGIT premium.
