St. Mary's County Government Announces Operational Status for January 11

LEONARDTOWN, MD – A [Winter Weather Advisory](#) is in effect for St. Mary's County, Maryland from 10 p.m. this evening, January 10, 2025, through 7 a.m. Saturday, January 11, 2025. Snowfall totals for Southern Maryland are expected between 1–3 inches.

St. Mary's County Government (SMCG) is announcing the following updates regarding operational status for Saturday, January 11, 2025.

Delayed Openings & Cancellations

- **Convenience Centers and St. Andrews Landfill:**
 - Opening at 10 a.m.
- **Department of Recreation & Parks Programs, Facilities, Museums, and Golf Course:**
 - Opening at 12 p.m.; all activities scheduled prior to noon are canceled.
 - Programs held on St. Mary's County Public Schools facilities are canceled for both January 11 and 12.
 - Wellness and Aquatic Center: Closed January 11; will reopen January 12.
- **St. Mary's County Libraries**
 - Opening at 12 p.m. (all branches).
 - The Lexington Park Library will be open on Sunday, per normal schedule.
- **St. Mary's County Public Schools**
 - All events scheduled for January 11 and 12 are canceled.
