LEONARDTOWN, MD – The Commissioners of St. Mary's County (CSMC) began their business meeting with an invocation and the pledge, followed by approval of the consent agenda.

The CSMC then presented proclamations in recognition of <u>National Domestic Violence</u> <u>Awareness Month</u>, <u>Economic Development Week</u>, <u>Red Ribbon Week</u>, and <u>National Disability</u> Employment Awareness Month.

The Commissioners then <u>presented</u> annual awards on behalf of the Commission for People with Disabilities, recognizing Janice Woods with the 2025 Care Partner Award, Cathy Dikerson with the 2025 Innovative Program Award, Derond Carroll with the 2025 Vicki Brown Award, and Pathways Inc. with the 2025 Notable Employer Award.
