LEONARDTOWN, MD – St. Mary's County Government's Department of Recreation & Parks (R&P) is hosting **Santa Claus** on **Saturday, December 6** at the **Wellness & Aquatics Center** (WAC) in Leonardtown for an unforgettable holiday experience. Join the professionals of Southern Maryland Divers for a short Discover Scuba course to learn the basics of scuba diving, then have your photo taken with Santa—underwater!

The event will be held from 12-4 p.m. at the Wellness & Aquatics Center on the College of Southern Maryland campus in Leonardtown (22950 Hollywood Rd in Leonardtown).

Registration is required, and participants must be age 8 or above. Anyone under 18 will need to have a parent on site to sign waivers.

Participants will need to provide a valid email address to access their photos with Santa. A link will be emailed after the event once the pictures have been processed.
