LEONARDTOWN, MD – The Commissioners of St. Mary's County (CSMC) began their [business meeting](#) with an invocation and the pledge, followed by approval of the consent agenda.

The CSMC then presented a [proclamation](#) in recognition of National Burn Awareness Week.

For their main agenda items, the commissioners took the following action:

- [Authorized](#) the Bay District Volunteer Fire Department request to hold a public hearing on February 24, 2026, to increase the Fire Tax Rate.
- [Authorized](#) the Department of Land Use & Growth Management to conduct a Public Hearing on February 24, 2026, to consider TEXT25-0112, amendment to allow Use Type 28 in the Resource Conservation Area Critical Area Overlay District.

During County Administrator Time, the CSMC took the following action:

- [Reviewed](#) future CSMC meeting agendas.
- [Received](#) a briefing on current the current school allocation policy and generation rates.
- [Approved](#) the agreement between the State of Maryland, Southern Maryland Navy Alliance, Inc. and CSMC to support projects at the St. Mary's County Regional Airport.
- [Approved](#) the St. Mary's Transit (STS) Public Transportation Agency Safety Plan.
- [Approved](#) the two option contracts with the State Highway Administration related to the disposition of a portion of real property located at the Governmental Center and the Board of Elections property, for the improvements/construction of sidewalks.
- [Discussed](#) the Community Reinvestment and Repair Fund.

The Commissioners then received a [legislative update](#) from the Office of the County Attorney.
